**Saint Gianna & Pietro Molla Maternity Home, located in Warsaw, North Dakota, supports women and their children as they make difficult decisions during unexpected pregnancies.**

### Family-Type Home Environment

The Home provides spacious and sunny bedrooms and bathrooms for expectant mothers and their children, a bright dining and kitchen area, warm living areas, and a beautiful chapel for quiet reflection. They also provide educational opportunities, including training related to job and parenting skills.

### Safe Space for Mothers & Children

The staff welcomes and stands by mothers of all ages, so they can find the right solutions for themselves and their children in a welcoming, nonjudgmental environment. The needs of the pregnant mom and child come first. Staff assists with finding a medical doctor and provide the necessary resources for the mental, physical, and emotional well-being of each woman and child.

### Spiritual Nourishment

It is the mission of the Home to bring the love of Christ to all women who come here. Many mothers who arrive on the doorstep come having experienced fear, rejection, and loneliness. The Home seeks to bring these mothers the love of Christ and the joy of experiencing that love. With God's grace, good things can come from even the most difficult situations. Women of all faiths are welcome.



## A LASTING IMPACT

In 2013, the Saint Gianna and Pietro Molla Maternity Home Endowment Fund was established at the Community Foundation as a sustainable, forever gift to the organization.

The endowment has been an ongoing resource, providing annual support for the Home's operating expenses, including safe shelter, food, clothing, education, and counseling for mothers in need.

## TAX BENEFITS

Endowments are a sustainable, forever gift that generally qualify for a deduction on both your federal and state income tax return. Many donors choose to establish or add to existing endowment funds to provide a vital source of funding that may allow a benefitting organization to carry on, even in lean years.

### 40% North Dakota Endowment Tax Credit

If you are a North Dakota taxpayer, you may be eligible to claim a credit of 40% on a minimum donation of \$5,000 to a qualified endowment at the Community Foundation through the North Dakota Charitable Income Tax Credit. By taking advantage of both the state tax credit and the federal tax deduction, you can significantly lower the net cost of your contribution and nearly triple its impact.

***The Saint Gianna and Pietro Molla Maternity Home Endowment Fund at the Community Foundation qualifies for this credit!***

**Individuals** may receive a North Dakota state tax credit for a contribution for \$5,000 or more (lump sum or aggregate in one year) to a qualified North Dakota endowment. The tax credit is 40% of the charitable deduction allowed by the IRS up to a maximum credit of \$10,000/year per taxpayer or \$20,000/year per couple filing jointly.

**Businesses** (C corporations, S corporations, estates, limited liability companies, trusts, and financial institutions) that pay North Dakota income tax may take a 40% credit up to a total of \$10,000 for gifts to a qualified endowment fund of a qualified North Dakota charity.

In all of the above, the credit may be carried forward for 3 additional tax years if it cannot all be used in one year.
